If the benchmark is met or exceeded, the option may become exercisable as to a maximum of 1,800 shares on each of March 1, 2008 and January 1 in each of the years 2009, 2010, 2011 and 2012, so long as the Reporting Person continues to be employed by the Company on the applicable vesting date.
- Restricted Stock Purchase pursuant to the Investment Share Program under issuer's Employee Equity Incentive Plan, shares vest 20% over 5 years from date of purchase.
